#### Satterfield-IRES Director's Brief Report 2012-2013

#### Summary of highlights


- Posted, interviewed and secured a superb candidate for the CRC II position in Behavioural Sustainability, jointly appointed with Psychology.
- In the process of working with the LIU institute to secure a CRC I hire in Food Security, from which joint spousal appointments or junior partnership with the CRC I candidate may occur. All posting, interviewing for both candidates are complete, negotiations are ongoing.
- Stewarded through decisions now at SAC two jointly-appointed Promotion & Tenure candidates (Mark Johnson and Leila Harris). Johnson is jointly appointed with Faculty of Science (IRES/ EOAS); Harris is jointly appointed in Faculty of Science and Faculty of Arts (IRES/GRSJ).
- Resolved significant number of problems regarding budgeting procedures and accounts set up within CFIS in order to align IRES with Faculty of Science protocols. This included new responsibilities for budgeting and reporting being downloaded entirely to departmental administration.
- Realignment of all faculty salary lines in IRES including CRC top ups; re-organization of all expenses following change in departmental ID.
- Re-organization viz. new peer review of teaching standards and protocols following move to FoS and new university requirements in general.
- Continuation of development of "Sustainability Assessment" Master's program.
- Resourcing new IT services with Central UBC IT following move from CFIS.
- Continuity of administrative staff with only one re-appointment, Graduate Program manager. The Finance office continued to work efficiently with 0.5 less FTE as compared to previous years.
- Training for staff members, most particularly in financial areas, continued following the attachment to Science, and the evolving UBC Budget systems.

#### Program Goals 2013-3014

- (1) Work with LIU, Forestry and Geography to secure partnership of CRC I hire of Ramankutty and Rhemtulla.
- (2) Ensure all departmental and university policies are complete and transparently online.
- (3) Ensure 2 or 3 more faculty become eligible as peer reviewers of teaching.
- (4) Complete curriculum proposals and plans for graduate and undergraduate teaching for the coming 5-10 year period.
- (5) Set up mentoring for two new faculty hires- Hannah Wittman and Jiaying Zhao and assist in completion of related CRC proposals.
- (6) Resolve ongoing legacies from CFIS transition regarding joint promotion cases and joint merit and PSA.
- (7) Hire new position in Sustainability Assessment.
- (8) Resolve Gunilla Oberg's appointment.
- (9) Re-examine RMES recruitment program and strategies.
- (10) Resolve Fisheries/IRES program differences for RMES students.


#### Research Funding

Our faculty is comprising of 10 faculty members, over half of whom are jointly appointed. They combine to a total of 7.35 FTE and held a total of **\$1,222,461.22** in funding in 2012/13. This averages to **\$166,321.25** per faculty. If faculty (n=2) who do not channel any funding through the department are excluded from this average; the mean funding per faculty is **\$189,494.04**.

In the future and in order to avoid any double counting, we will separate funds that are funneled through and managed by IRES faculty verses funds IRES faculty, as PI, bring to UBC more broadly.



# Student Funding

Our students held a total of **\$531,844** in external funding in the year 2012/13 averaging **\$19697.93** per student. This reflects our ability to attract top, competitive students and to the substantial effort we have put into mentoring student's capacity to develop successful proposals, both tri-council and related funding and with regard to their proposals for thesis and dissertation work.
